Member Criteria	1.	Pin level: Master Coordinator or above
	2.	MUST earn \geq HK\$69,000 per month in COMMISSIONS from one (1) or more BDCs during each calendar quarter.
	3.	Qualified and personally sponsored 3 Unfranchise Owners in one (1) Calendar quarter out of the previous Calendar year.

Remarks:

1. Only Speakers Bureau Members shall be eligible to speak/train* at publicly scheduled NMTSS events in which an admission fee is charged for attendance. Without posting on NMTSS, NUOT, B5 may NOT charge.
2. All Speakers Bureau Members within the immediate geographic location of UBP, LS, DC Association are REQUIRED to be an actively participating member of this association.
3. All Speakers Bureau Members shall be given the opportunity to pre-purchase tickets prior to being offered to the general public.
